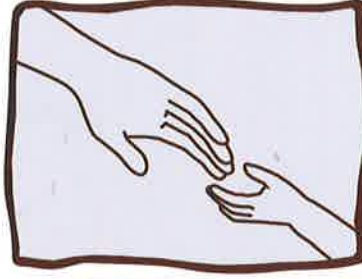

Tuition Organization for Private Schools (TOPS) for Kids is a state-approved school tuition organization that disperses scholarships funded by the Arizona tuition tax credit program.

TOPS for Kids help children receive a Arizona tuition scholarships to attend the private school of their choice. TOPS also helps Arizona parents maximize their tuition dollars by utilizing the tax credit program. Scholarships are given from the contributions of Arizona taxpayers who use the tuition tax credit program.

Lauren's Institute for Education (L.I.F.E.) qualifies as a TOPS for Kids recipient therefore individuals or married couples can donate to TOPS for Kids and designate the contribution directly to L.I.F.E.

CORPORATE DONATIONS

How Can Your Class C Corporation or Insurance Carrier Help Students?

1. Identify your company's corporate income tax liability and determine how much you would like to donate versus pay to the state this fiscal year. (Your company can donate the entire corporate tax liability amount).
2. Contact The Arizona Leadership Foundation (ALF) at info@arizonaleader.org to start the process.
3. ALF will file a one-page form with the Department of Revenue (DOR), asking for approval for the donation/credit. ALF will send you a copy of this form. The DOR will respond within 20 days on whether or not funds are available under the current fiscal year cap.
4. Within 10 days of DOR approval (DOR and ALF will notify you), your company must send a check or wire to the Arizona Leadership Foundation for the contribution.
5. When you file your company's taxes, you will take the corporate income tax credit on the Standard 120 Form and file a 335 Form as well listing the credit amount.

Your Corporation Can Help Low-Income Children at NO COST through the Corporate Benefits of the Arizona Corporate Tax Credit Scholarship Program:

- Receive a 100% tax credit for every dollar donated.
- No cost – Participating corporations just redirect funds they must already pay to the state.
- The program is paying the way for an educated workforce that will greatly contribute to the betterment of our communities.

Participating companies do not have to be domiciled in Arizona; the only requirement is that they have tax liability with the state. Dollars can fund scholarships for children in a specific region(s), schools or across the state.
