Donate through a no cost Individual Tax Credit: download brochure

In Arizona you can choose where some of your tax money goes through the <u>Arizona</u> <u>Private School Tax Credit Law</u>. This law allows you to donate to an organization that gives out scholarships to private schools. It is a direct tax credit so you get all the money you donate directly off the amount you owe in Arizona taxes. You can request what private school you want your donation to go to. This is a great way to donate to LIFE at no cost to you!

LIFE works with two main School Tuition Organizations (STOs) that accept these tax credit donations and then awards scholarships.

- Tuition Organization for Private Schools (TOPS) for Kids
- <u>Arizona Tuition Connection</u>

Donor application is easy and you can complete it online in just a few minutes.

Donate and it directly reduces the amount of Arizona tax money you owe, which means it is no cost to you.

Please don't forget to select Lauren's Institute for Education on the Recommendation section of the application.

These organizations do not share donor information, so if you would like to be recognized, please inform us of your donation.

Remember donors with enough tax liability can also donate to a charter school and public school without it affecting their donation to LIFE.



Donate through Corporate Matching:

Many corporations participate in matching programs, where an employee can designate part of their check to an organization and the company will match the donation up to a certain dollar amount. Please consider having your employer add us to their list of recipients.

Monthly Donation:

Consider giving a monthly donation. We can set up a recurring monthly donation to be pulled after the 1st or 15th each month, in an amount you select, from a card you designate. Monthly contributions can be started and stopped anytime throughout the year.
